2. Data Subjects

3. Purpose of personal data collection

The personal data stored in the customer registers of Yrttiaika are used to manage customer relations, to inform about services, for marketing purposes, and for the development / planning of services and other operations and for other similar purposes.

4. Personal data stored in the register

5. Rights of Data Subjects

The data subject has the following rights, and all requests concerning their use must be made to the address <u>kauppa@yrttiaika.fi</u>

Right of review

The data subject may review the personal data stored by us.

Right of rectification

The data subject may ask us to rectify any erroneous or incomplete personal information.

Right of objection

The data subject may object to the use of their personal data if they feel that their data have been processed unlawfully.

Direct marketing ban

The data subject may forbid the use of their data for direct marketing purposes.

Right of removal

The data subject may request the removal of their data if their processing is not necessary. We will review the request, after which we will either remove the data or notify of a justified reason why the data cannot be removed.

It must be noted that the controller may possess a legal obligation or another right to not remove any data. The controller is obliged to retain all accounting materials for the period (10 years) specified in the Accounting Act (paragraph 2, § 10). This is why no accounting materials may be removed until the retention period has expired.

Withdrawing consent

If the processing of the personal data of the data subject is based on consent only, and not on e.g. customership or membership, the data subject may withdraw their consent.

The data subject may appeal any decision to the data protection supervisor

The data subject may demand the limitation of the processing of contested data until the matter is resolved.

Right of appeal

The data subject may file a complaint with the data protection supervisor if they feel that we are in violation of currently valid data protection legislation in our processing of the personal data.

6. Regular data sources

Cookies are small text files that are stored on the user's terminal by their browser. Cookies often include an anonymous individual identifier that we can use to identify and count all browsers that visit our website.
